PASSPORT FACILITIES FOR CHILDREN

An application has been received at this office for passport facilities to be granted to who is a person under the age of 21 years and the below-mentioned particulars are brought to your notice in order that such facilities may be given.

Persons under 21 years of age may not be granted passport facilities without the written consent of their legal guardian (i.e. normally the father) except where the applicant is married or is a member of Zambian Forces.

The mother, or any other person claiming during the life-time of the father to be the legal guardian, must produce the Court Order committing the child to her, or that person's custody. If the father is dead a statement to that effect should be submitted by the mother and the death certificate produced.
